Call to Order

Mayor Sewell called the council meeting to order at 7:00 p.m. followed by the pledge of allegiance and invocation.

Agenda Changes

There were no changes made to the agenda.

Approval of Minutes

Mayor Sewell asked for a motion to approve the minutes of the October 21, 2013 regular council meeting.

A motion was made by Council Member Crawford seconded by Council Member Shepherd to approve the minutes of the regular council meeting held on October 21, 2013. The motion carried unanimously.

Election Results

Mayor Sewell asked for a motion to acknowledge and approve the election results for those offices with no opposition.

Council Member Parrish seconded by Council Member Wilson motioned to approve the election results for those offices with no opposition. The motion carried unanimously.

Municipal Court of the City of Bremen Ordinance

Mayor Sewell stated that this is an ordinance update in which we received copies of the proposed changes at last month's council meeting so that we could have time to review them.

City Attorney, Sam Price stated that there is an addition that we need to make to the copies of the ordinance that you received last month. In section 34-5-B, the wording "*or by mailing as permitted by state law for the offense charged*" should be added to the third line.

Mayor Sewell asked for a motion to approve the ordinance with the addition stated by Sam Price.

A motion was made by Council Member Wilson seconded by Council Member Crawford to approve the municipal court ordinance as presented by City Attorney, Sam Price. Motion carried unanimously.

Open to the Public

Mayor Sewell opened the floor to the public and asked if anyone had anything to bring before the Mayor and Council.

Marcelle Johnson was present and briefly discussed the Leadership Haralson program. She stated that applications for admissions to the 2014 Leadership Haralson Academy will be accepted through January 6, 2014. She explained the course and stated that it begins on January 10, 2014 and ends on April 29, 2014.

Mrs. Johnson also mentioned the Hospital Gift Shop. She stated that it is operated by volunteers and all of the proceeds are given back to the hospital. She invited everyone to stop by and see the gift selection offered.
