

#### Exceptions.

The provisions of this article shall not apply to or affect the following person or sales:

1. Persons selling goods pursuant to an order or process of a court of competent jurisdiction.
2. Persons acting in accordance with their powers and duties as public officials.
3. Any person selling or advertising for sale an item or items of personal property which are specified named or described in the advertisement and which separate items do not exceed five in number.

#### Issuance of Permit.

A permit shall be issued under this article to any one person only twice within a 12-month period and no such license shall be issued for more than three consecutive calendar days. Each license issued under this article must be prominently displayed on the premises upon the yard sale is conducted throughout the entire period of the permit sale. Items for sale must be moved inside at dusk.

#### Information to be Filed.

The information to be filed with the Police Department pursuant to this article shall be as follows:

1. Name of person conducting the sale.
2. Name and owner of the property on which the sale is to be conducted, and consent of owner if applicant is other than the owner.
3. Location at which the sale is to be conducted.
4. Number of days of sale.
5. Date and nature of any past sale.
6. Relationship or connection applicant may have had with any other person conducting the sale and the date of or dates of such sale.
7. Whether or not applicant has been issued any other vendor's license by any local, state or federal agency.
8. Sworn statement or affirmation by the person signing that the information therein given is full and true and known by him to be so.

#### Penalties for conducting yard sale with out a permit:

1. First offense, written warning.
2. Second offense, \$100. fine.
3. Third offense, \$250. fine.
4. Summons for court appearance.

ORDINANCE

WHEREAS, the Mayor and Council of the City of Bremen find that there exists in the City of Bremen yard sales; the Mayor and Council of the City of Bremen find it is in the best interest of the City to appropriate the powers set for to deal with such problems and conditions.

NOW, THEREFORE, let it be resolved and it is hereby resolved by the City of Bremen as follows AN ORDINANCE GOVERNING AND SETTING THE YARD SALE PERMIT REQUIRED FOR DEALING WITHIN THE CITY OF BREMEN.

ARTICLE 1. YARD SALES

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Goods shall mean and include any goods, warehouse merchandise or other property capable of being the object of sale regulated under this article.

Yard Sales shall mean and include all sales entitled "garage sale", "yard sale", "attic sale", "rummage sale", "flea market sale", or any similar casual sale of tangible personal property which is advertised by any means whereby the public at large is or can be made aware of the sale.

Penalty.

Any person conducting a yard sale without being properly licensed therefor or who shall have violated any of the other terms and regulations of this article shall, upon conviction, be punished as provided.

Permit

It shall be unlawful for any person to conduct a yard sale in the city without first filing with the Police Department the information specified and obtaining from such Police Department a permit to do so, to be known as a "yard sale permit." There will be no charge for the yard sale permit.
