CALL TO ORDER

Mayor Sewell called the regular scheduled council meeting to order at 7:00 p.m. followed by the pledge of allegiance and invocation.

REVIEW & MODIFICATION OF THE AGENDA

Mayor Sewell added item number 5a. to the agenda to approve a change with the city's legal representation.

APPROVAL OF MINUTES

Mayor Sewell asked for a motion to approve the minutes from the September 18, 2023 regular council meeting.

Council Member Thomason abstained due to being absent the September 18 council meeting.

APPROVAL OF SEXUAL HARASSMENT POLICY
